PROJECT NAME: CONSULTANCY SERVICES FOR PREPARATION OF THE CAVITE HISTORICAL MASTER PLAN

APPROVED BUDGET FOR THE CONTRACT: Eighteen Million Three Hundred Ninety Five Thousand Six Hundred Twenty Seven Pesos Only (PhP18, 395,627.00)

Only Carunungan and Partners, Co. was shortlisted upon determining that its eligibility documents are complete using the Quality Based Evaluation Procedure. Evaluation of its technical proposals determined that Carunungan and Partners, Co. have PASSED and is compliant and responsive with all the requirements, thus their financial proposals was scheduled for evaluation.
