

BAC RESOLUTION NO. 2020-137

RECOMMENDING AWARD OF CONTRACT FOR SECURITY SERVICES FOR TIEZA PRINCIPAL OFFICE A FOR ONE (1) YEAR

WHEREAS, after conducting the required Pre-Procurement Conference, the Bids and Awards Committee (BAC), through the BAC Secretariat, posted **August 27- Sept. 21, 2020** an Invitation to Bid for the public bidding for the **Procurement of One Year (1) Security Services for TIEZA Principal** of the Tourism Infrastructure and Enterprise Zone Authority;

WHEREAS, an invitation to bid for the **Procurement of One Year (1) Security Services for TIEZA Principal Office** was posted in the Philippine Electronic Government Electronic Procurement System (PhilGEPS), TIEZA Website and at conspicuous place of the TIEZA Bldg. premises;

WHEREAS, the Approved Budget Contract (ABC) for the project is in the total amount of Five Million Four Hundred Fifteen Thousand Eight Hundred Ninety Seven Pesos and 36/100 (Php5,415,897.36);

WHEREAS, **RED PLANET SECURITY AGENCY, INC.** is the only one (1) prospective bidder responded to the Invitation and secured bid documents;

WHEREAS, during the opening of bids on September 21, 2020 held via Microsoft Teams Video Conference attended by BAC in quorum, end-user, TWG for Goods, COA representative and bidder's representative among others, the bid of **RED PLANET SECURITY AGENCY, INC.** was evaluated using the PASS/FAIL criterion, the result reflected as follows:

WHEREAS, pursuant to Section 32 Rule IX of the 2016 Revised Implementing Rules and Regulations of the Republic Act 9184 the bid proposal of **RED PLANET SECURITY AGENCY, INC.** was subjected to detailed bid evaluation;

WHEREAS, the TWG found the bid of **RED PLANET SECURITY AGENCY, INC.** to be complete and without computational nor arithmetical errors, pursuant to Sec. 36 Rule X of the 2016 Revised IRR of R. A. 9184, thus it recommended that its bid be identified and declared as Solely Bidder, and after it be subjected to Post Qualification Process;

WHEREAS, the BAC adopted the recommendation of the TWG to identify **RED PLANET SECURITY AGENCY, INC.** as the Single Calculated and Responsive Bid for the project and to subject the said bidder to post qualification process;

WHEREAS, the BAC declared the bid of **RED PLANET SECURITY AGENCY, INC.** as the Single Calculated and Responsive Bid and the same be subjected to the post-qualification process;

WHEREAS, **RED PLANET SECURITY AGENCY, INC.** was accordingly informed of BAC's findings, and the former was required to submit the post-qualification documents (latest income; business tax returns, Medical Certificate, Drug Test Clearance with certification, Neurologic/Psychiatric Clearance, SOSIA Security Guard License Card, NBI Clearance, PNP and Brgy. Clearance) which was complied within five days from receipt of the Notice to Comply;

WHEREAS, the TWG conducted the required Post Qualification on the bid of **RED PLANET SECURITY AGENCY, INC.** in accordance with Section 36 of the IRR of RA 9184 by validating, verifying, and ascertaining the authenticity of the documents submitted by **RED PLANET SECURITY AGENCY, INC.**, the veracity of the statements contained in those documents;

WHEREAS, after verifying and validating that the documents submitted by **RED PLANET SECURITY AGENCY, INC.** are authentic, in order, and contained true and accurate statements or information, the TWG recommended to the Bids and Awards Committee (BAC) that the **RED PLANET SECURITY AGENCY, INC.**'s bid be declared as the Single Calculated and Responsive Bid (SCRB). The TWG also recommended to the BAC that the contract for the **Procurement of One Year (1) Security Services for TIEZA Principal Office** in the amount of **Five Million Four Hundred Four Thousand, One Hundred Thirty Nine Thousand and Six Centavos (5,404,139.06)** be awarded to **RED PLANET SECURITY AGENCY, INC.**;

WHEREAS, finding the TWG's report to be meritorious, the BAC approved and adopted the recommendation to declare the bid **RED PLANET SECURITY AGENCY, INC.** as the Single Calculated and Responsive Bid (SCRB) and to award the contract to said bidder;

WHEREAS, based on the result of the Bid Evaluation and Post Qualification, the BAC finds that the bid of **RED PLANET SECURITY AGENCY, INC.** is compliant with and responsive to all the requirements and conditions in the bidding documents; and **RED PLANET SECURITY AGENCY, INC.** has the necessary legal, technical, and financial capacity to comply with the fulfillment of the contract;

WHEREFORE, BE IT RESOLVED AS IT HEREBY RESOLVED, to declare the bid of **RED PLANET SECURITY AGENCY, INC.** as the Single Calculated and Responsive Bid (SCRB) and to recommend to the Head of Procuring Entity (HOPE) that the contract for the project in the amount of **Five Million Four Hundred Four Thousand, One Hundred Thirty Nine Thousand and Six Centavos (5,404,139.06)** be awarded to **RED PLANET SECURITY AGENCY, INC.**


