

**RECOMMENDING AWARD OF CONTRACT FOR THE
PROCUREMENT OF SUPPLY AND DELIVERY OF TWO (2)
UNITS OF DEWATERING PUMPS AND OTHER LINE ITEMS
FOR THE USE OF CLUB INTRAMUROS GOLF COURSE**

WHEREAS, after conducting the required Pre-Procurement Conference, the Bids and Awards Committee (BAC), through the BAC Secretariat, posted on December 13, 2019 to January 6, 2019 an Invitation to Bid for the public bidding for the Procurement of Supply and Delivery of Two (2) Units of Dewatering pumps and Other Line Items for the Use of Club Intramuros Golf Course in the websites of TIEZA and Phil-GEPS, and in conspicuous places within the premises of the TIEZA Office;

WHEREAS, the Approved Budget Contract (ABC) for the project is in the total amount of One Million Eight Hundred Three Thousand Three Hundred Eighteen 77/100 (Php 1,803,318.77) Pesos;

WHEREAS, only (1) prospective bidder responded to the Invitation and secured bid documents, namely;

1. Gotesco Marketing, Inc.

WHEREAS, during the opening of bids on January 6, 2020 held at the TIEZA Building attended by BAC in quorum, COA representative, the following are the result of the preliminary assessment on the bid proposals submitted by the bidders:

WHEREAS, pursuant to Section 32 Rule IX of the 2016 Revised Implementing Rules and Regulations of the Republic Act 9184 the bid proposal of Gotesco Marketing, Inc. was subjected to detailed bid evaluation;

WHEREAS, the bid proposal of Gotesco Marketing, Inc. having complied with the requirements of the bidding was evaluated in detail, without correction for computational error and was identified as the Single Calculated Bid for the public bidding for the Procurement of Supply and Delivery of Two (2) Units of Dewatering pumps and Other Line Items for the Use of Club Intramuros Golf Course;

WHEREAS, the TWG found the bid of Gotesco Marketing, Inc. to be complete and without computational nor arithmetical errors, pursuant to Sec. 34 Rule X of the 2016 Revised IRR of R. A. 9184, thus it recommended that its bid be identified and declared as Single Calculated Bid, and after it be subjected to Post Qualification Process;

WHEREAS, the BAC adopted the recommendation of the TWG to identify Gotesco Marketing, Inc. as the Single Calculated Bid for the project and to subject the said bidder to post qualification process;

WHEREAS, the BAC declared the bid of Gotesco Marketing, Inc. as the Single Calculated Bid and the same be subjected to the post-qualification process;

WHEREAS, Gotesco Marketing, Inc. was accordingly informed of BAC's findings, and the former was required to submit the post-qualification documents (latest income and business tax returns) which were complied within five days from receipt of the Notice to Comply;

WHEREAS, the TWG conducted the required Post Qualification on the bid of Gotesco Marketing, Inc. in accordance with Section 34 of the IRR of RA 9184 by validating, verifying, and ascertaining the authenticity of the documents submitted by Gotesco Marketing, Inc. and the veracity of the statements contained in those documents;

WHEREAS, after verifying and validating that the documents submitted by Gotesco Marketing, Inc. are authentic, in order, and contained true and accurate statements or information, the TWG recommended to the Bids and Awards Committee (BAC) that the Gotesco Marketing, Inc.'s bid be declared as the Single Calculated and Responsive Bid (SLRC). The TWG also recommended to the BAC that the contract for the Procurement of Supply and Delivery of Two (2) Units of Dewatering pumps and Other Line Items for the Use of Club Intramuros Golf Course in the amount of One Million Seven Hundred Seventy One Thousand Two Hundred Ten 67/100 (Php 1,771,210.67) Pesos be awarded to Gotesco Marketing, Inc.;

WHEREAS, finding the TWG's report to be meritorious, the BAC approved and adopted the recommendation to declare the bid of Gotesco Marketing, Inc. as the Single Calculated and Responsive Bid (SCRB) and to award the contract to said bidder;

WHEREAS, based on the result of the Bid Evaluation and Post Qualification, the BAC finds that the bid of Gotesco Marketing, Inc. is compliant with and responsive to all the requirements and conditions in the bidding documents; and Gotesco Marketing, Inc. has the necessary legal, technical, and financial capacity to undertake the project;

WHEREFORE, BE IT RESOLVED AS IT HEREBY RESOLVED, to declare the bid of Gotesco Marketing, Inc. as the Single Calculated and Responsive Bid (SCRB) and to recommend to the Head of Procuring Entity (HOPE) that the contract for the project in the amount of One Million Seven Hundred Seventy One Thousand Two Hundred Ten 67/100 (Php 1,771,210.67) Pesos be awarded to Gotesco Marketing, Inc..
