**A RESOLUTION RECOMMENDING AWARD TO VALLEY SOUTH MOTOR WORKS FOR THE
CHECK UP TRANSMISSION & REPAIR FOR TOYOTA FORTUNER AS PER P.R. NO.
20-01-0006**

WHEREAS, the Administration and Finance Sector submitted to the Bids and Awards Committee a Purchase Request for the **CHECK UP TRANSMISSION & REPAIR FOR TOYOTA FORTUNER**, with an Approved Budget for the Contract (ABC) of One Hundred Twenty Nine Thousand One Hundred Fifty Eight Pesos and 40/100 Pesos (Php129, 158.40);

WHEREAS, on March 12, 2020 the BAC through BAC Secretariat posted in the websites of TIEZA and PhilGEPS and at conspicuous places in the premises of TIEZA, Request for Quotation announcing procurement requirements for the project through Negotiated Procurement (Small Value Procurement), an alternative method prescribed under Section 53.9 of the IRR of R.A. 9184 however, suspended until June 14, 2020 due to the Covid-19 pandemic.

WHEREAS, on June 15-18, 2020 procurement was resumed, with the revised Request for Quotation, however, procurement failed due to non-compliance of the bidder;

WHEREAS, on July 1-6, 2020, the project was re-posted in the websites of TIEZA and PhilGEPS;

WHEREAS, the BAC Secretariat likewise re-sent Request for Quotation to the following suppliers;

2. ASELL TGLOBAL, INC.
3. AMBASSADOR INMOGO

WHEREAS, before the deadline of submission on July 6, 2020 only one (1) supplier, The Valley South Motor Works, submitted its online password protected quotation with the following offer:
