A RESOLUTION RECOMMENDING AWARD TO BITSOFTECHNOLOGY CO. FOR THE SUPPLY AND DELIVERY OF ICE MAKER AND 4 OTHER LINE ITEMS AS PER PR NO. 670/ 668/ 19-10-0799/ 19-12-0980

WHEREAS, Various Departments submitted to the Bids and Awards Committee a request for the **SUPPLY AND DELIVERY OF ICE MAKER AND 4 OTHER LINE ITEMS** with an Approved Budget for the Contract (ABC) of **Three Hundred Sixteen Thousand Six Hundred Ninety Eight Pesos (PHP 316,698.00)**;
