**A RESOLUTION RECOMMENDING AWARD TO COVER AND PAGES CORPORATION, FOR THE PRINTING, SUPPLY AND DELIVERY OF FLYERS FOR THE USE OF BUDD INVESTMENT PROMOTIONS AS PER P.R. NO. 19-11-0939**

**WHEREAS**, the Business Development Department submitted to the Bids and Awards Committee a Purchase Request for the **PRINTING, SUPPLY AND DELIVERY OF FLYERS FOR THE USE OF BUDD INVESTMENT PROMOTIONS**, with an Approved Budget for the Contract (ABC) of **Two Hundred Thousand Pesos (Php200,000.00)**;

**WHEREAS**, on December 9-13, 2019 the BAC through BAC Secretariat posted in the websites of TIEZA and PhilGEPS and at conspicuous places in the premises of TIEZA, Request for Quotation announcing procurement requirements for the project through Negotiated Procurement (Small Value Procurement), an alternative method prescribed under Section 53.9 of the IRR of R.A. 9184;

**WHEREAS**, the BAC Secretariat likewise sent Request for Quotation to the following suppliers;

1. Cover and Pages Corporation
2. Fastrack Manufacturing
3. VJ Press

**WHEREAS**, before the deadline of submission on December 13, 2019, six (6) suppliers namely, Cover and Pages Corporation, Metrocolor Corporation, Visual Color, Inc., Innovation Printshoppe, Inc. and Dependable Packaging and Printing House Corporation;

**WHEREAS**, during the opening of sealed quotation on December 13, 2019, the offers of Metrocolor Corporation, Visual Color, Inc. and Innovation Printshoppe, Inc. were disqualified for non-compliance with the required delivery period;

**WHEREAS**, Dependable Packaging and Printing House Corporation was disqualified for non-submission of Secretary's Certificate and non-compliance with the required delivery period;

**WHEREAS**, Cover and Pages Corporation's documents were evaluated by the BAC with the result as follows:


