



# PUBLIC CONSULTATION

## PROPOSED REDUCTION OF FEES RELATED TO THE APPLICATION FOR REGISTRATION OF TOURISM ENTERPRISES FOR THE GRANT AND AVAILMENT OF INCENTIVES UNDER R.A. 11534 OR "THE CORPORATE RECOVERY AND TAX INCENTIVES FOR ENTERPRISES ACT"

In light of the passage into law of R.A. 11534 or the “Corporate Recovery and Tax Incentives for Enterprises Act (CREATE Act)” and pursuant to the national policy prescribing that the new/revised rates shall, as much as possible, be uniform for similar or comparable services and functions offered by other government entities; TIEZA is currently evaluating the revision of its filing and registration fees for tourism related enterprises.

The purpose of this online consultation form is to gather the comments and feedbacks of the private and public sector, more importantly the tourism stakeholders, regarding TIEZA’s proposal to reduce the fees on the filing of application and the registration of tourism enterprises for the grant and availment of incentives under R.A. 11534 or the “Corporate Recovery and Tax Incentives for Enterprises (CREATE) Act.”

Thus, a more competitive application fees that will lessen the burden on the investors’ expenses especially for the micro, small, medium enterprises (MSMEs) and existing enterprises that intend to apply with TIEZA and avail of the incentives under R.A. 11534 is hereby proposed as follows:
