

BAC RESOLUTION NO. 2024-067

WHEREAS, an *Invitation to Bid* was posted in the TIEZA Website, Phil-GEPS and at conspicuous place of the TIEZA building premises inviting prospective bidders to participate in the public bidding of **SUPPLY, DELIVERY AND INSTALLATION OF 6 SETS 4-CLUSTER WORK STATION AND 5 OTHER LINE ITEMS FOR THE USE OF PEPD OFFICE AS PER PR NO. 23-11-0586**;

WHEREAS, the *Approved Budget for the Contract* is in the amount of **One Million Two Hundred Ten Thousand Pesos (₱ 1,210,000.00)** only;

WHEREAS, in the opening of bids on February 5, 2024 and subsequent evaluation thereof, **PENITON TRADING** was found complying with the requirements and conditions as specified in the bidding documents, thus, identified as the Lowest Calculated Bidder as prescribed under Section 32 of the 2016 Revised IRR of R.A. 9184;

Further, the BAC resolves to recommend the award of contract for the project to **PENITON TRADING** in the total amount of **SEVEN HUNDRED EIGHTY-EIGHT THOUSAND PESOS (₱788,000.00)** only.


