WHEREAS, an Invitation to Bid for the **VARIOUS TOURISM FACILITIES DIPACULAO, AURORA** was posted in the Phil-GEPS, TIEZA Website, and at conspicuous place of the TIEZA Bldg. premises inviting prospective bidders to participate in the procurement for the **VARIOUS TOURISM FACILITIES DIPACULAO, AURORA**;

WHEREAS, the **Approved Budget for the Contract** is in the amount of **Fifty Million Nine Hundred Ninety-Four Thousand Five Hundred Thirty Pesos and Forty-Four Centavos (₱ 50,994,530.44)** only;

WHEREAS, one (1) prospective bidder responded to the invitation and submitted its bid proposal/s, namely;

WHEREAS, having passed the detailed evaluation, the Technical Working Group (TWG) recommended to the Bids and Awards Committee (BAC) to identify the proposal of **REND ENTERPRISES & GENERAL CONTRACTOR JV WITH MRRM TRADING & CONSTRUCTION** as the *Single Calculated bid* for the **VARIOUS TOURISM FACILITIES DIPACULAO, AURORA** and to subject said proposal to post qualification process in accordance with Rule X, Section 34 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, being part of the post qualification process, **REND ENTERPRISES & GENERAL CONTRACTOR JV WITH MRRM TRADING & CONSTRUCTION** was also required to submit their *Latest Income Tax Returns (ITR)* and *Business Tax Returns within the last six months preceding the date of bid of submission* which they were able to submit on time;

WHEREAS, the Technical Working Group (TWG) recommends to the Bids and Awards Committee (BAC) to declare the proposal of **REND ENTERPRISES & GENERAL CONTRACTOR JV WITH MRRM TRADING & CONSTRUCTION** as the *Single Calculated and Responsive Bid* for the **VARIOUS TOURISM FACILITIES DIPACULAO, AURORA**. Further recommends to the Bids and Awards Committee (BAC) to award the contract for the project to **REND ENTERPRISES & GENERAL CONTRACTOR JV WITH MRRM TRADING & CONSTRUCTION** in the total amount of **FIFTY MILLION NINE HUNDRED TWENTY-SEVEN THOUSAND ONE HUNDRED FIFTEEN PESOS AND TWENTY-FOUR CENTAVOS (₱ 50,927,115.24)** only;

NOW, THEREFORE, in view of the foregoing, the Bids and Awards Committee (BAC) hereby resolves to accept, approve and adopt the recommendation of the Technical Working Group (TWG) to identify the proposal of **REND ENTERPRISES & GENERAL CONTRACTOR JV WITH MRRM TRADING & CONSTRUCTION** as the *Single Calculated and Responsive Bid* for the **VARIOUS TOURISM FACILITIES DIPACULAO, AURORA**. Further, the BAC *resolves* to recommend the award of contract for the project to **REND ENTERPRISES & GENERAL CONTRACTOR JV WITH MRRM TRADING & CONSTRUCTION** in the total amount of **FIFTY MILLION NINE HUNDRED TWENTY-SEVEN THOUSAND ONE HUNDRED FIFTEEN PESOS AND TWENTY-FOUR CENTAVOS (₱ 50,927,115.24)** only.
