

**BAC RESOLUTION NO. 2022-136**

**WHEREAS**, an invitation to bid for the *SUPPLY AND DELIVERY OF 10 UNITS GOLF CART FOR THE USE OF CLUB INTRAMUROS GOLF COURSE AND 2 UNITS FOR THE USE OF ZAMBOANGA GOLF COURSE* was posted in the TIEZA Website, Phil-GEPS and at conspicuous place of the TIEZA building premises;

**WHEREAS**, the Approved Budget for the Contract is in the total amount of *Five Million One Hundred twenty thousand Pesos Only (₱ 5,120,000.00)* based on the following line items:

- ▶ 10 units Golf Cart of CIGC -₱ 4,000,000.00 as per PR no.22-03-0109
- ▶ 2 units Golf Carts of ZGC-₱ 1,120,000.00 as per PR no. 22-04-0202

**WHEREAS**, Invitation to Bid no: 22-07-0005 as posted, states “Suppliers may bid for both or either of the two stated procurement requirements. Bid received in excess of the ABC shall be automatically rejected at bid opening”;

**WHEREAS**, the Technical Working Group (TWG) recommends to the Bids and Awards Committee (BAC) to declare the proposal of *THE TURF COMPANY* as the Single Calculated and Responsive Bid for the *SUPPLY AND DELIVERY OF 10 UNITS GOLF CART FOR THE USE OF CLUB INTRAMUROS GOLF COURSE*. Further recommends to the Bids and Awards Committee (BAC) to award the contract for the project to *THE TURF COMPANY* in the total amount of **Four Million Pesos Only (P 4,000,000.00)**;
