

BAC RESOLUTION NO. 2023-033-A

WHEREAS, an invitation to bid for the *PROCUREMENT OF JANITORIAL SERVICES FOR THE TIEZA PRINCIPAL OFFICE AND INTRAMUROS AND RIZAL'S BAGUMBAYAN LIGHT AND SOUND MUSEUM FOR THE PERIOD OF ONE (1) YEAR AS PER PR NO. 22-11-0628* was posted in the Phil-GEPS, TIEZA Website, and at conspicuous place of the TIEZA Bldg. premises;

WHEREAS, the Approved Budget for the Contract is *Three Million Six Thousand Five Hundred Five & 20/100 Pesos Only (₱ 3,006,505.20)*;

WHEREAS, three (3) prospective bidders responded to the Invitation and secured bid documents, namely;

1. *ONE MERIT GLOBAL JANITORIAL SERVICES INCORPORATED*
2. *D' TRIUMPH CLEANERS AND ALLIED SERVICES, INC.*
3. *EURO JANITORIAL SERVICES*

WHEREAS, during the opening of bids on December 7, 2022 held via Microsoft Teams and attended by BAC in quorum and the bidder's representative among others, a preliminary examination of bids was conducted with result as follows:

WHEREAS, The Technical Working Group then proceeded in the evaluation of bid submitted by *D' TRIUMPH CLEANERS AND ALLIED SERVICES, INC.*;

Further recommends to the Bids and Awards Committee (BAC) to award the contract for the project to **D' TRIUMPH CLEANERS AND ALLIED SERVICES, INC.** in the total amount of **Three Million Pesos Only (P 3,000,000.00)**;


