

## **BAC RESOLUTION NO. 2023-025**

**WHEREAS**, an invitation to bid for the *SUPPLY AND DELIVERY OF MANAGED PRINT SERVICES FOR THREE (3) YEAR SUBSCRIPTION PERIOD AS PER PR NO. 22-08-0439* was posted in the TIEZA Website, Phil-GEPS and at conspicuous place of the TIEZA building premises;

**WHEREAS**, the Approved Budget for the Contract is in the amount of *Twenty Nine Million Seven Hundred Thousand Pesos Only (₱ 29,700,000.00)*;

**WHEREAS**, the Technical Working Group (TWG) recommends to the Bids and Awards Committee (BAC) to declare the proposal of **MULTIBIZ INTERNATIONAL CORP.** as the Single Calculated and Responsive Bid for the **SUPPLY AND DELIVERY OF MANAGED PRINT SERVICES FOR THREE (3) YEAR SUBSCRIPTION PERIOD AS PER PR NO. 22-08-0439.** Further, recommends to the Bids and Awards Committee (BAC) to award the contract for the project to **MULTIBIZ INTERNATIONAL CORP.** in the total amount of **Twenty Five Million Fifteen Thousand Eight Hundred Sixty-One Pesos Only (P25,015,861.00);**
