GATDULA** (hereafter referred to as "**CONSULTANT**").

RECITALS

WHEREAS, TIEZA is desirous that the CONSULTANT execute **PROCUREMENT OF CONSULTING SERVICES FOR THE 2022 CUSTOMER SATISFACTION SURVEY AS PER PR NO. 22-08-0420** (hereafter called "the Services") and TIEZA has accepted the bid for **ONE MILLION NINE HUNDRED FIFTY-ONE THOUSAND FORTY PESOS (Php1,951,040.00)** (hereafter called the "Contract Price") by the CONSULTANT for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THEREFORE, for and in consideration of the foregoing, the parties agree as follows:
