

CONTRACT AGREEMENT

THIS AGREEMENT, made this 14 day SEP 14 2022 2022 in CITY OF MANILA between:

The **TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY**, an attached body corporate of the Department of Tourism by virtue of Republic Act No. 9593, with principal office address at 6th and 7th Floors, Tower 1 Double Dragon Plaza, DD Meridian Park, Macapagal Avenue corner EDSA Extension, Pasay City, Metro Manila, represented herein by its Chief Operating Officer, **MARK T. LAPID** (hereafter referred to as "**TIEZA**"),

-and-

TWIN DRAGON CONSTRUCTION, with principal office address at M.A. Roxas St. Tabing Dagat, Odiongan, Romblon, represented herein by its General Manager, **ALYKHAN F. FERNANDEZ** (hereafter called the "**CONTRACTOR**").

RECITALS

WHEREAS, TIEZA is desirous that the contractor execute the **CONSTRUCTION OF MANGROVE FOREST AND AQUA CULTURE FACILITIES LIBERTAD SANCTUARY, ODIONGAN, ROMBLON** and TIEZA has accepted the bid for **EIGHT MILLION FOUR HUNDRED FORTY-NINE THOUSAND ONE HUNDRED THIRTY-ONE PESOS AND SEVENTY-SEVEN CENTAVOS (PhP8,449,131.77)** (hereafter called "the Contract Price") by the **CONTRACTOR** for the execution and completion of such Works and the remedying of any defects therein.

NOW THEREFORE, for and in consideration of the foregoing, the parties agree as follows:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - j. General and Special Conditions of Contract;
 - k. Invitation to Apply for Eligibility and to Bid;
 - l. Instructions to Bidders;
 - m. Notice of Award of Contract and the Bidder's *conforme*;
 - n. Performance Security
 - o. Program of Work (POW) / Terms of Reference;
 - p. Specifications;
 - q. TWG Evaluation and Recommendation/Resolution;
 - r. Warranty Security;
 - s. Other supporting documents.

The enumeration above shall not be construed as a limitation to the inclusion of other relevant documents submitted and/or required to be submitted by applicable law, issuances, or TIEZA.
