

BAC RESOLUTION NO. 2022 - 94-A

WHEREAS, an invitation to bid for the **CONSTRUCTION OF MUNICIPAL FOOD TERMINAL/PUBLIC MARKET PANDAN, ANTIQUE** was posted in the Phil-GEPS, TIEZA Website, and at conspicuous place of the TIEZA Bldg. premises;

WHEREAS, the Approved Budget for the Contract is two *Million nine hundred eighty eight Thousand two Hundred forty five and 46/100 Pesos Only* (₱ 2,988,245.46);

WHEREAS, one prospective bidder responded to the Invitation and secured bid documents, namely;

WHEREAS, the Technical Working Group (TWG) recommends to the Bids and Awards Committee (BAC) to declare the proposal of ***NESMARK CONSTRUCTION ENTERPRISES*** as the Single Calculated and Responsive Bid for the ***CONSTRUCTION OF MUNICIPAL FOOD TERMINAL/PUBLIC MARKET PANDAN, ANTIQUE***. Further recommends to the Bids and Awards Committee (BAC) to award the contract for the project to ***NESMARK CONSTRUCTION ENTERPRISES*** in the total amount of ***Two Million nine Hundred forty one Thousand Six Hundred Fifty Nine & 06/100 Pesos Only (₱ 2,941,659.06)***.

NOW, THEREFORE, in view of the foregoing, the Bids and Awards Committee (BAC) hereby resolves to accept, approve and adopt the recommendation of the Technical Working Group (TWG) to identify the proposal of ***NESMARK CONSTRUCTION ENTERPRISES*** as the Single Calculated and Responsive Bid for the ***CONSTRUCTION OF MUNICIPAL FOOD TERMINAL/PUBLIC MARKET PANDAN, ANTIQUE***. Further, the BAC *resolves* to recommend the award of contract for the project to said contractor in the amount of ***Two Million nine Hundred forty one Thousand Six Hundred Fifty Nine & 06/100 Pesos Only (₱ 2,941,659.06)***.
