WHEREAS, an *Invitation to Bid* was posted in the TIEZA Website, Phil-GEPS and at a conspicuous place of the TIEZA building premises inviting prospective bidders to participate in the public bidding of the **SUPPLY AND DELIVERY OF NEW SUBSCRIPTION LICENSES SKETCHUP PRO FOR (3) YEARS AS PER PR NO. 24-02-0132** with an Approved Budget for the Contract of **₱ 1,808,750.00**;

WHEREAS, in the detailed evaluation conducted on the submittal of the lone participating bidder adopting Section 32 of the 2016 Revised IRR of R.A. 9184, the proposal of **IT AVENUE GENERAL MERCHANDISE** amounting to **₱ 1,750,000.00** came out as the *Single Calculated Bid*;

Further, the BAC resolves to recommend awarding the contract for the project to **IT AVENUE GENERAL MERCHANDISE** in the total amount of **ONE MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (₱1,750,000.00)** only.
