

CONTRACT AGREEMENT

THIS AGREEMENT, made this ____ day of _____ 2023 in _____ between:

The **TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY**, an attached body corporate of the Department of Tourism by virtue of Republic Act No. 9593, with principal office address at 6th and 7th Floors, Tower 1 Double Dragon Plaza, DD Meridian Park, Macapagal Avenue corner EDSA Extension, Pasay City, Metro Manila, represented herein by its Chief Operating Officer, **MARK T. LAPID** (hereafter referred to as "**TIEZA**"),

-and-

AMIGO ENTERTAINMENT TECHNOLOGIES, INC., with principal office address at Patricia Bldg. Magallanes, Makati City, represented herein by its Authorized Representative, **RENOLD P. SOL** (hereafter called the "**CONTRACTOR**").

The proof that the parties' representatives are duly authorized for this purpose are attached hereto as **ANNEX A**, series, and made an integral part hereof.

RECITALS

WHEREAS, TIEZA is desirous that the contractor execute the **PROCUREMENT OF THE AESTHETIC LIGHTING OF THE MEMORIAL CROSS AND COLLANADE AT MT. SAMAT SHRINE OF VALOR, PILAR, BATAAN UNDER DESIGN AND BUILD SCHEME** and TIEZA has accepted the bid for **FORTY-TWO MILLION EIGHT HUNDRED SEVENTY THOUSAND FOUR HUNDRED FORTY-THREE PESOS AND SIXTY-ONE CENTAVOS (Php42,870,443.61)** (hereafter called "the Contract Price") by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THEREFORE, for and in consideration of the foregoing, the parties agree as follows:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - o. Program of Work (POW) / Terms of Reference;
 - p. Specifications;
 - q. TWG Evaluation and Recommendation/Resolution;
 - r. Warranty Security;

The enumeration above shall not be construed as a limitation to the inclusion of other relevant documents submitted and/or required to be submitted by applicable law, issuances, or TIEZA.

3. In consideration of the payment to be made by TIEZA to the CONTRACTOR, the latter binds and obligates itself to faithfully undertake and accomplish the WORKS and remedy any defect in conformity with all the provisions of this Agreement in all aspects.
4. TIEZA hereby covenants to pay the CONTRACTOR, in consideration of the execution and completion of the Works and the remedying of defects, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed herein.
