

# CONTRACT AGREEMENT

(Contract No. 2023- )

THIS AGREEMENT, made this 03 OCT 2023 day of October 2023 in Dasmariñas City, Cavite between:

The **TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA)**, an attached body corporate of the Department of Tourism by virtue of Republic Act No. 9593 holding office address at 6<sup>th</sup> and 7<sup>th</sup> Floors, Tower 1 Double Dragon Plaza, DD Meridian Park, Macapagal Avenue corner EDSA Extension, Pasay City, Metro Manila, represented herein by its Chief Operating Officer, **MARK T. LAPID** duly authorized for this purpose under Board Resolution \_\_\_\_\_, Series of \_\_\_\_\_ (copy of which is attached as Annex A);

**PACEER SECURITY AGENCY, INC.** with principal office address at Blk 9 Lot 2 South Garden Homes, Congressional Road, Brgy. Salitran III, Dasmariñas City, Cavite, represented here by **CARL JASON V. ALINDOG** authorized under Resolution No. \_\_\_\_\_, Series of \_\_\_\_\_ (copy of which is attached as Annex B).

## RECITALS

WHEREAS, TIEZA is desirous that the SUPPLIER execute the **1 LOT SECURITY SECURITY SERVICES FOR MOUNT DATA HOTEL AS PER PR NO. 23-06-0316** and TIEZA has accepted the bid for the supply of those goods and services in the sum of **TWO MILLION TWO HUNDRED FIFTY-ONE THOUSAND PESOS (PHP2,251,000.00)** (hereafter called "the Contract Price").

**NOW THEREFORE**, for and in consideration of the foregoing, the parties agree as follows:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents, as applicable, shall be attached, deemed to form, and be read and construed as part of this Agreement:
  - a. Addenda and/or Supplemental/Bid Bulletins, if any;
  - b. BAC Resolution/s;
  - c. Bid Data Sheet;
  - d. General Conditions of Contract;
  - e. Memorandum for the COO recommending award;
  - f. Notice of Award of Contract and the Bidder's *conforme* thereto;
  - g. Performance Security;
  - h. Schedule of Requirements;
  - i. Special Conditions of Contract;
  - j. Supplier's Bid, including the Technical and Financial Proposal, Procuring Entity's Invitation to Bid and all other documents/statements submitted for the Procuring Entity's bid evaluation;
  - k. Technical Specifications;
  - l. Terms of Reference (TOR);
  - m. TWG Evaluation and Recommendation/Resolution;
  - n. Other contract documents that may be required by existing laws or by TIEZA. SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract's execution, such as the Notice to Proceed, Variation Orders and Warranty Security, shall likewise form part of the Contract.

The enumeration above shall not be construed as a limitation to the inclusion of other relevant documents submitted and/or required to be submitted by applicable law, issuances, or TIEZA.

3. In consideration of sum of **TWO MILLION TWO HUNDRED FIFTY-ONE THOUSAND PESOS (PHP2,251,000.00)** or such other sums as may be ascertained, SUPPLIER agrees to provide the security services in accordance with its bid.
4. TIEZA agrees to pay the above-mentioned sum in accordance with the terms of the bidding.

**IN WITNESS THEREOF**, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the date and place first above-written.


