WHEREAS, the General Services Division submitted to the Bids and Awards Committee a request for the **SUPPLY AND DELIVERY OF OFFICE SUPPLIES FOR GSD STOCKS 2ND QUARTER AS PER PR NO. 24-03-0192**, with an Approved Budget for the Contract (ABC) of **ONE HUNDRED EIGHTY THREE THOUSAND ONE HUNDRED NINETY-NINE PESOS ONLY (Php 183,199.00)**;
