LAPID** duly authorized for this purpose under Board Resolution _____, Series of _____ (copy of which is attached as Annex A);

TERRATEK BUSINESS CONSULTING AND SERVICES, with principal office address at 440 Pureza St. Sta. Mesa, Barangay 425, Sampaloc, Manila, Metro Manila, represented here by **JONATHAN S. ALCARTADO** authorized under Resolution No. _____, Series of _____ (copy of which is attached as Annex B).

RECITALS

WHEREAS, TIEZA is desirous that the SUPPLIER execute the **PROCUREMENT OF 9 UNITS INTERNET SUBSCRIPTION FOR THE USE AT PROVINCIAL TRAVEL TAX UNITS AS PER NO. 24-02-0106** and TIEZA has accepted the bid for the supply of those goods and services in the sum of **THREE HUNDRED SEVEN THOUSAND EIGHT HUNDRED PESOS (PHP307,800.00)** (hereafter called "the Contract Price").

NOW THEREFORE, for and in consideration of the foregoing, the parties agree as follows:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents, as applicable, shall be attached, deemed to form, and be read and construed as part of this Agreement:
 - a. Addenda and/or Supplemental/Bid Bulletins, if any;
 - b. BAC Resolution/s;
 - c. Bid Data Sheet;
 - d. General Conditions of Contract;
 - e. Memorandum for the COO recommending award;
 - f. Notice of Award of Contract and the Bidder's *conforme* thereto;
 - g. Performance Security;
 - h. Schedule of Requirements;
 - i. Special Conditions of Contract;
 - j. Supplier's Bid, including the Technical and Financial Proposal, Procuring Entity's Invitation to Bid and all other documents/statements submitted for the Procuring Entity's bid evaluation;
 - k. Technical Specifications;
 - l. Terms of Reference (TOR);
 - m. TWG Evaluation and Recommendation/Resolution;
 - n. Other contract documents that may be required by existing laws or by TIEZA. SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract's execution, such as the Notice to Proceed, Variation Orders and Warranty Security, shall likewise form part of the Contract.

In consideration of sum of **THREE HUNDRED SEVEN THOUSAND EIGHT HUNDRED PESOS (PHP307,800.00)** or such other sums as may be ascertained, SUPPLIER agrees to provide the **PROCUREMENT OF 9 UNITS INTERNET SUBSCRIPTION FOR THE USE AT PROVINCIAL TRAVEL TAX UNITS AS PER NO. 24-02-0106** in accordance with its bid.
- 4. TIEZA agrees to pay the above-mentioned sum in accordance with the terms of the bidding.
