WHEREAS, before the deadline for submission of quotations on April 29, 2024, at 1:00 pm, **LRIGA TRADING, 8 TIMES 8 GENERAL MERCHANDISE, JLEBQUEEN CONSUMER GOODS TRADING, KQAA CONSUMER GOODS TRADING and ZASHEN FASHION** submitted their sealed quotation/s;

WHEREAS, **KQAA CONSUMER GOODS TRADING** was disqualified due to non-submission of Annual Income Tax Return;

WHEREAS, **ZASHEN FASHIONS** was disqualified due to incomplete specifications;
