## RECITALS

WHEREAS, TIEZA is desirous that the CONTRACTOR execute the **TOURIST REST AREA, BARANGAY HILAMONAN, KABANKALAN CITY, NEGROS OCCIDENTAL** and TIEZA has accepted the bid for **NINE MILLION EIGHT HUNDRED NINETY-ONE THOUSAND FIVE HUNDRED EIGHTY-TWO PESOS AND TWENTY-TWO CENTAVOS (PhP9,891,582.22)** (hereafter called "the Contract Price") by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

**NOW THEREFORE**, for and in consideration of the foregoing, the parties agree as follows:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - i. Financial and Technical Component;
  - j. General and Special Conditions of Contract;
  - k. Invitation to Apply for Eligibility and to Bid;
  - l. Instructions to Bidders;
  - m. Notice of Award of Contract and the Bidder's *conforme*;
  - n. Performance Security
  - o. Program of Work (POW) / Terms of Reference;
  - p. Specifications;
  - q. TWG Evaluation and Recommendation/Resolution;
  - r. Warranty Security;

The enumeration above shall not be construed as a limitation to the inclusion of other relevant documents submitted and/or required to be submitted by applicable law, issuances, or TIEZA.

In consideration of sum of for **NINE MILLION EIGHT HUNDRED NINETY-ONE THOUSAND FIVE HUNDRED EIGHTY-TWO PESOS AND TWENTY-TWO CENTAVOS (PhP9,891,582.22)** or such other sums as may be ascertained, CONTRACTOR agrees to the construction of the **TOURIST REST AREA, BARANGAY HILAMONAN, KABANKALAN CITY, NEGROS OCCIDENTAL** in accordance with its bid.
- 4. TIEZA agrees to pay the above-mentioned sum in accordance with the terms of the bidding.
