**WHEREAS**, the Administrative Services Department – General Services Division submitted to the Bids and Awards Committee a request for the **PROCUREMENT OF 30 PCS FIRE EXTINGUISHER HFC - 236 FA, 20 LBS FOR REFILLING OF FIRE EXTINGUISHER HFC - 236 FA, 20 LBS AS PER PR NO. 24-07-0383**, with an Approved Budget for the Contract (ABC) of **SIX HUNDRED SIXTY THOUSAND PESOS ONLY (Php 660,000.00)**;
