

BAC RESOLUTION NO. 2024-222-A

WHEREAS, an Invitation to Bid was posted in the Phil-GEPS, TIEZA Website, and at a conspicuous place of the TIEZA Bldg. premises inviting prospective bidders to participate in the public bidding of **SECURITY SERVICES FOR TIEZA NON-OPERATING PROPERTIES IN LUZON FOR PERIOD OF THREE (3) YEARS AS PER PR. NO. 24-04-0215** with an Approved Budget for the Contract of **₱ 37,128,509.91**;

WHEREAS, two (2) prospective bidders responded to the Invitation and submitted their respective bid proposals before the deadline for submission, namely;

- 1. ITAWES SECURTY PROACTIVE AGENCY, INC.**
- 2. PACEER SECURITY AGENCY INC.**

WHEREAS, the BAC in quorum, in the presence of the bidders, and the observers, among others, conducted the preliminary examination of bids on **August 12, 2024**;

WHEREAS, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders and Section 30 of the 2016 Revised IRR of RA 9184, the two (2) bidders were rated passed by the committee, subject however to detailed evaluation of bids;

WHEREAS, the Technical Working Group as tasked by the Bids and Awards Committee conducted the detailed evaluation of the two (2) bid proposals as provided in Section 32 of the 2016 Revised IRR of RA 9184;

WHEREAS, in the evaluation, **ITAWES SECURTY PROACTIVE AGENCY, INC.** was disqualified due to *non*-submission of Articles of Incorporation in support of SEC Registration, and the *submitted Monthly Disposition Report (MDR)* lacks proof that it was *issued by SOSIA*;

WHEREAS, the proposal of **PACEER SECURITY AGENCY INC.** with a bid amount of **₱ 33,133,024.44** having complied with the requirements and conditions as specified in the bidding documents was identified as the Lowest Calculated Bid for the project;

WHEREAS, subsequently, as provided in Sec. 34 Rule X of the 2016 Revised IRR of R.A. 9184, the bid proposal of **PACEER SECURITY AGENCY INC.** was subjected to post-qualification process;

WHEREAS, accordingly, the Technical Working Group (TWG), verified, validated, and ascertained all statements made and documents submitted by **PACEER SECURITY AGENCY INC.**;

WHEREAS, as part of the post-qualification process, **PACEER SECURITY AGENCY INC.** was also required to submit their *Latest Income Tax Returns (ITR)* and *Business Tax Returns within the last six months preceding the date of bid submission* which they were able to submit on time;

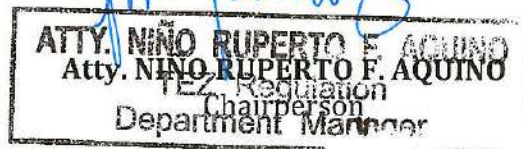
WHEREAS, the post-qualification showed that the proposal of **PACEER SECURITY AGENCY INC.** complies with and is responsive to the requirements and conditions as specified in the bidding documents;


WHEREAS, the Technical Working Group (TWG) recommends to the Bids and Awards Committee (BAC) to declare the proposal of **PACEER SECURITY AGENCY INC.** as the Lowest Calculated and Responsive Bid for the procurement of **SECURITY SERVICES FOR TIEZA NON-OPERATING PROPERTIES IN LUZON FOR PERIOD OF THREE (3) YEARS AS PER PR. NO. 24-04-0215.** Further, the TWG recommends awarding the contract for the said project to **PACEER SECURITY AGENCY INC.** in the total amount of **THIRTY THREE MILLION ONE HUNDRED THIRTY THREE THOUSAND TWENTY FOUR PESOS AND FORTY FOUR CENTAVOS (₱ 33,133,024.44)** only;

NOW, THEREFORE, in view of the foregoing, the Bids and Awards Committee (BAC) hereby resolves to approve, accept, and adopt the recommendations of the Technical Working Group (TWG) to declare the proposal of **PACEER SECURITY AGENCY INC.** as the Lowest Calculated and Responsive Bid for the procurement of **SECURITY SERVICES FOR TIEZA NON-OPERATING PROPERTIES IN LUZON FOR PERIOD OF THREE (3) YEARS AS PER PR. NO. 24-04-0215.** Further, the BAC recommends awarding the contract for the said project to **PACEER SECURITY AGENCY INC.** in the total amount of **THIRTY THREE MILLION ONE HUNDRED THIRTY THREE THOUSAND TWENTY FOUR PESOS AND FORTY FOUR CENTAVOS (₱ 33,133,024.44)** only.
