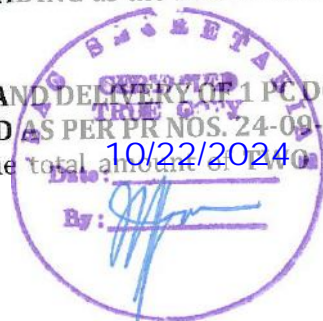
WHEREAS, **PANTRONICS INTERNATIONAL CORPORATION** was disqualified due to incomplete specifications;
