

BAC RESOLUTION NO. 2024-209-B

WHEREAS, an Invitation to Bid was posted in the Phil-GEPS, TIEZA Website, and at a conspicuous place of the TIEZA Bldg. premises inviting prospective bidders to participate in the public bidding of **TOURIST REST AREA, BARANGAY ANINGALAN, SAN REMIGIO, ANTIQUE** with an Approved Budget for the Contract of **₱ 9,901,959.86**;

WHEREAS, four (4) prospective bidders submitted their respective bid proposals before the deadline on **July 29, 2024** in response to the invitation posted for the re-bidding of the project, namely:

- 1. D' X-MEN BUILDERS CORPORATION**
- 2. AIDEN AND AYN CONSTRUCTION**
- 3. SANIYA CONSTRUCTION**
- 4. NDM CONSTRUCTION SERVICES**

WHEREAS, the BAC in quorum, in the presence of the bidders, and the observers, among others, conducted the preliminary examination of bids on **July 29, 2024**;

WHEREAS, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders and Section 30 of the 2016 Revised IRR of RA 9184, the four (4) bidders were rated passed by the committee subject however to detailed evaluation of bids;

WHEREAS, the Technical Working Group as tasked by the Bids and Awards Committee conducted the detailed evaluation of the four (4) bid proposals as provided in Section 32 of the 2016 Revised IRR of RA 9184;

WHEREAS, in the evaluation, **D' X-MEN BUILDERS CORPORATION** was disqualified due to non-submission of the Articles of Incorporation in support of SEC Registration, the submitted Cash Flow is presented in 3 quarters, thus the required completion period of 150 cd is exceeded, and use of the Letterhead/Logo of the Department of Agriculture in the Cash Flow;

WHEREAS, AIDEN AND AYN CONSTRUCTION was also disqualified for submitting a Cash Flow presented in 4 quarters, thus the required completion period of 150 cd is likewise exceeded;

WHEREAS, the proposal of **SANIYA CONSTRUCTION** with a bid amount of **₱ 9,376,714.93** having complied with the requirements and conditions as specified in the bidding documents was identified as the Lowest Calculated Bid for the project;

WHEREAS, subsequently, as provided in Sec. 34 Rule X of the 2016 Revised IRR of R.A. 9184, the Technical Working Group (TWG) as tasked by the Bids and Awards

TOURIST REST AREA, BARANGAY ANINGALAN, SAN REMIGIO, ANTIQUE

Committee (BAC) conducted the post-qualification process on the bid proposal of **SANIYA CONSTRUCTION**;

WHEREAS, accordingly, the Technical Working Group (TWG), verified, validated, and ascertained all statements made and documents submitted by **SANIYA CONSTRUCTION**;

WHEREAS, as part of the post-qualification process, **SANIYA CONSTRUCTION** was also required to submit their *Latest Income Tax Returns (ITR)* and *Business Tax Returns within the last six months preceding the date of bid submission* which they were able to submit on time;

WHEREAS, the post-qualification showed that the proposal of **SANIYA CONSTRUCTION** complies with and is responsive to the requirements and conditions as specified in the bidding documents;

WHEREAS, the Technical Working Group (TWG) recommends to the Bids and Awards Committee (BAC) to declare the proposal of **SANIYA CONSTRUCTION** as the Lowest Calculated and Responsive Bid for the procurement of the project **TOURIST REST AREA, BARANGAY ANINGALAN, SAN REMIGIO, ANTIQUE**. Further, the TWG recommends awarding the contract for the said project to **SANIYA CONSTRUCTION** in the total amount of **NINE MILLION THREE HUNDRED SEVENTY SIX THOUSAND SEVEN HUNDRED FOURTEEN PESOS AND NINETY THREE CENTAVOS (₱ 9,376,714.93)** only;

NOW, THEREFORE, in view of the foregoing, the Bids and Awards Committee (BAC) hereby resolves to accept, approve and adopt the recommendations of the Technical Working Group (TWG) to declare the proposal of **SANIYA CONSTRUCTION** as the Lowest Calculated and Responsive Bid for the procurement of the project **TOURIST REST AREA, BARANGAY ANINGALAN, SAN REMIGIO, ANTIQUE**. Further, the **BAC** recommends awarding the contract for the said project to **SANIYA CONSTRUCTION** in the total amount of **NINE MILLION THREE HUNDRED SEVENTY SIX THOUSAND SEVEN HUNDRED FOURTEEN PESOS AND NINETY THREE CENTAVOS (₱ 9,376,714.93)** only.
