WHEREAS, TIEZA is desirous that the CONTRACTOR execute the **DEVELOPMENT OF NATURE PARK BORONGAN EASTERN SAMAR** and TIEZA has accepted the bid for **THIRTEEN MILLION THREE HUNDRED TWENTY-TWO THOUSAND FOUR HUNDRED SIXTY-SIX PESOS AND SEVENTY CENTAVOS (PhP13,322,466.70)** (hereafter called "the Contract Price") by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THEREFORE, for and in consideration of the foregoing, the parties agree as follows:

4. TIEZA agrees to pay the above-mentioned sum in accordance with the terms of the bidding
