

# CONTRACT AGREEMENT

(Contract No. 2024- 068)

THIS AGREEMENT, made this NOV 08 2024 day of MANILA 2024 in MANILA between:

The **TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA)**, an attached body corporate of the Department of Tourism by virtue of Republic Act No. 9593 holding office at 6<sup>th</sup> and 7<sup>th</sup> Floors, Tower 1 Double Dragon Plaza, DD Meridian Park, Macapagal Avenue corner EDSA Extension, Pasay City, Metro Manila, represented herein by its Chief Operating Officer, **MARK T. LAPID**, duly authorized for this purpose under Board Resolution \_\_\_\_\_, Series of \_\_\_\_\_ (copy of which is attached as Annex A);

## RECITALS

WHEREAS, TIEZA is desirous that the CONTRACTOR execute the **RECONSTRUCTION AND RETROFITTING OF SAN GUILLERMO PARISH CHURCH BACOLOR PAMPANGA** and TIEZA has accepted the bid for **TWENTY-NINE MILLION SIX HUNDRED NINETY-SEVEN THOUSAND SEVENTY-TWO PESOS AND SIXTY-NINE CENTAVOS (Php29,697,072.69)** (hereafter called "the Contract Price") by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

**NOW THEREFORE**, for and in consideration of the foregoing, the parties agree as follows:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents, as applicable, shall be attached, deemed to form, and be read and construed as part of this Agreement:

  - e. Cash Flow Chart;
  - f. Construction Schedule (PERT/CPM);
  - g. Drawings/Plans;
  - h. Eligibility requirements, documents/statements;
  - i. Financial and Technical Component;
  - j. General and Special Conditions of Contract;
  - k. Invitation to Apply for Eligibility and to Bid;
  - l. Instructions to Bidders;
  - m. Notice of Award of Contract and the Bidder's *conforme*;
  - n. Performance Security
  - o. Program of Work (POW) / Terms of Reference;
  - p. Specifications;
  - q. TWG Evaluation and Recommendation/Resolution;
  - r. Warranty Security;
  - s. Quantity take-off;
  - t. Other contract documents that may be required by existing laws or by TIEZA. CONTRACTOR agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract's

execution, such as the Notice to Proceed, Variation Orders and Warranty Security, shall likewise form part of the Contract.

The enumeration above shall not be construed as a limitation to the inclusion of other relevant documents submitted and/or required to be submitted by applicable law, issuances, or TIEZA.

- In consideration of sum of for **TWENTY-NINE MILLION SIX HUNDRED NINETY-SEVEN THOUSAND SEVENTY-TWO PESOS AND SIXTY-NINE CENTAVOS (PhP29,697,072.69)** or such other sums as may be ascertained, CONTRACTOR agrees to the **RECONSTRUCTION AND RETROFITTING OF SAN GUILLERMO PARISH CHURCH BACOLOR PAMPANGA** in accordance with its bid.
- TIEZA agrees to pay the above-mentioned sum in accordance with the terms of the bidding.
