A RESOLUTION RECOMMENDING AWARD OF PURCHASE/JOB ORDER TO THE TURF COMPANY, INC. FOR THE PROCUREMENT OF 18 PCS BATTERY (8 VOLTS) DEEP CYCLE 190AH AND OTHER LINE ITEMS FOR GOLF CARTS USE AS PER PR NO. 24-10-0569

WHEREAS, the Club Intramuros Golf Course submitted to the BAC a Purchase Request for the **PROCUREMENT OF 18 PCS BATTERY (8 VOLTS) DEEP CYCLE 190AH AND OTHER LINE ITEMS FOR GOLF CARTS USE AS PER PR NO. 24-10-0569**, with an Approved Budget for the Contract (ABC) of **THREE HUNDRED SEVENTY FIVE THOUSAND PESOS ONLY (Php 375,000.00)**;

WHEREAS, Section 50.c of the 2016 Revised IRR of R.A. 9184 provides that Direct Contracting may be resorted to by the concerned procuring entity under ... Those sold by an exclusive dealer or manufacturer which does not have sub dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP;

WHEREAS, the supplier / manufacturer must prove through proper documentation that it is the sole source of the said goods, equipment or services required;

WHEREAS, Korea Battery Co., LTD. issued a Letter of Exclusive Distributorship that **THE TURF COMPANY, INC.** is selected to act as its authorized distributor for the Philippines and is qualified to sell and service Newmax Batteries as a certified distributor for the period of March 15, 2024 up to March 15, 2026;

WHEREAS, the BAC sent a Request for Quotation (RFQ) to the identified direct supplier namely **THE TURF COMPANY, INC.** for the **PROCUREMENT OF 18 PCS BATTERY (8 VOLTS) DEEP CYCLE 190AH AND OTHER LINE ITEMS FOR GOLF CARTS USE AS PER PR NO. 24-10-0569**;

WHEREAS, in response, **THE TURF COMPANY, INC.** submitted its quotation/ proposal for the project with a total bid price of **THREE HUNDRED SIXTY TWO THOUSAND FIVE HUNDRED PESOS ONLY (Php 362,500.00)**;

WHEREAS, the BAC has found the request to be reasonable having met the conditions for the use of such alternative method of procurement as provided for under the Implementing Rules and Regulations of RA 9184;

WHEREAS, having complied with the requirements of the bidding as prescribed under Section 50.c – Direct Contracting method of procurement of the 2016 Revised IRR of R.A. 9184 and for submitting a price advantageous to the Government, **THE TURF COMPANY, INC.** is eligible for the award of contract/ Purchase/ Job Order;

NOW, THEREFORE, IN VIEW OF THE FOREGOING, the Bids and Awards Committee hereby resolves to recommend the award of contract for the **PROCUREMENT OF 18 PCS BATTERY (8 VOLTS) DEEP CYCLE 190AH AND OTHER LINE ITEMS FOR GOLF CARTS USE AS PER PR NO. 24-10-0569** to **THE TURF COMPANY, INC.** in the total amount of **THREE HUNDRED SIXTY TWO THOUSAND FIVE HUNDRED PESOS ONLY (Php 362,500.00)**;
