A RESOLUTION RECOMMENDING AWARD OF PURCHASE/JOB ORDER TO PHILCOPY CORPORATION FOR THE PROCUREMENT OF 6 BXS KYOCERA TONER TK-1175 AND OTHER LINE ITEM FOR THE USE OF NAIA TERMINAL 1 AND 3 AS PER PR NO. 24-10-0580

WHEREAS, the Travel Tax Department submitted to the BAC a Purchase Request for the **PROCUREMENT OF 6 BXS KYOCERA TONER TK-1175 AND OTHER LINE ITEM FOR THE USE OF NAIA TERMINAL 1 AND 3 AS PER PR NO. 24-10-0580**, with an Approved Budget for the Contract (ABC) of **EIGHTY SEVEN THOUSAND FOUR HUNDRED SIXTY PESOS ONLY (Php 87,460.00)**;

WHEREAS, Section 50.c of the 2016 Revised IRR of R.A. 9184 provides that Direct Contracting may be resorted to by the concerned procuring entity under ... Those sold by an exclusive dealer or manufacturer which does not have sub dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP;

WHEREAS, the supplier / manufacturer must prove through proper documentation that it is the sole source of the said goods, equipment or services required;

WHEREAS, the Kyocera Document Solutions Asia Limited issued a Certificate that **PHILCOPY CORPORATION** is the exclusive distributor in marketing and servicing Kyocera Document Solutions brand multi-functional products, laser printers and multi-functional peripheral, software solutions, including related consumables and spare parts in the Philippines;

WHEREAS, the BAC sent a Request for Quotation (RFQ) to the identified direct supplier namely **PHILCOPY CORPORATION** for the **PROCUREMENT OF 6 BXS KYOCERA TONER TK-1175 AND OTHER LINE ITEM FOR THE USE OF NAIA TERMINAL 1 AND 3 AS PER PR NO. 24-10-0580**;

WHEREAS, in response, **PHILCOPY CORPORATION** submitted its quotation/ proposal for the project with a total bid price of **EIGHTY SEVEN THOUSAND FOUR HUNDRED SIXTY PESOS ONLY (Php 87,460.00)**;

WHEREAS, the BAC has found the request to be reasonable having met the conditions for the use of such alternative method of procurement as provided for under the Implementing Rules and Regulations of RA 9184;

WHEREAS, having complied with the requirements of the bidding as prescribed under Section 50.c – Direct Contracting method of procurement of the 2016 Revised IRR of R.A. 9184 and for submitting a price advantageous to the Government, **PHILCOPY CORPORATION** is eligible for the award of contract/ Purchase/ Job Order;

NOW, THEREFORE, IN VIEW OF THE FOREGOING, the Bids and Awards Committee hereby resolves to recommend the award of contract for the **PROCUREMENT OF 6 BXS KYOCERA TONER TK-1175 AND OTHER LINE ITEM FOR THE USE OF NAIA TERMINAL 1 AND 3 AS PER PR NO. 24-10-0580** to **PHILCOPY CORPORATION** in the total amount of **EIGHTY SEVEN THOUSAND FOUR HUNDRED SIXTY PESOS ONLY (Php 87,460.00)**;




