RECITALS

WHEREAS, TIEZA is desirous that the CONSULTANT execute **CONSULTANCY SERVICES FOR THE PREPARATION OF THE REGIONAL TOURISM DEVELOPMENT PLAN FOR CENTRAL LUZON** (hereafter called "the Services") and TIEZA has accepted the bid for **FORTY-FIVE MILLION TWO HUNDRED THIRTEEN THOUSAND FOUR HUNDRED PESOS (Php45,213,400.00)** (hereafter called "the Contract Price") by the CONSULTANT for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THEREFORE, for and in consideration of the foregoing, the parties agree as follows:
